You are listed in the current real estate tax records of Loudoun County as the owner of a parcel of land abutting, adjacent to, or across the road from certain property that is the subject of a public hearing before the Loudoun County Planning Commission for the above referenced zoning application. You may also be a representative of a nearby homeowners association (HOA) that is located in the vicinity of the above-referenced application. The Property referenced in this letter is Lot L2A in University Center and is more particularly described as Loudoun County PIN 039-18-2610.

Research Place 45145, LLC is proposing a zoning concept plan amendment to amend a restriction included as part of the rezoning (ZMAP-1992-0004) and zoning concept plan amendment (ZCPA-1992-0009) approved on January 6, 1993 which apply to the Property. The concept development plan approved with these applications includes a note, Note B, which restricts Parcel L to research and development uses. Parcel L encompasses the Property. As part of the proposed zoning concept plan amendment application, the Applicant requests that Note B, which restricts the Property to research and development uses, be removed from the concept development plan to enable the Property to develop with permitted PD-RDP uses.


